<p><b>2. Composition / Information on Ingredients</b></p> <p>Deferred set Asphalts are mixtures of aggregates and fluxed bitumens or bitumen emulsions. The flux oil is petroleum based. The fluxing agent will usually be in the range of 0.7% - 1.5% of the mixture and will typically be around 1.2%. Water based emulsions will not exceed 10% of the mixture.</p> <p><b>3.</b> For further details of the specification refer to the relevant Technical Data Sheet.</p>	<p><b>6. Accidental Release Measures</b></p> <p><b>Personal Precautions</b> Ensure the temperature of the Asphalt does not present a Safety Hazard. Wear overalls and gloves.</p> <p><b>Environmental Precautions</b> Entry into watercourses should be avoided.</p> <p><b>Methods for Cleaning</b> No Special requirements</p>
<p><b>4. Hazards Identification</b></p> <p>These products are <b>NOT</b> classified as <b>hazardous</b> in accordance any statutory legislation such as CHIP. If used as intended we do not envisage any COSHH Risk Exposure Rating. The main hazards presented by Asphalt Deferred set products depends on the temperature of the material. Deferred set Asphalt containing flux has a typical maximum temperature of 120°C when mixed. Emulsion based products are mixed typically at ambient temperatures.</p> <p>The following hazards may apply:</p> <ul style="list-style-type: none"> <li>• Hot materials may burn the skin.</li> <li>• Fumes from Asphalt – Deferred Set are unlikely to be hazardous when laid in open air situations, but there may be a risk to health by continuous inhalation of high vapour concentrations which might arise in confined or semi-confined spaces.</li> <li>• Emulsion from Asphalt – Deferred Set products is unlikely to be hazardous when in contact with the skin since it rapidly converts to a cold bitumen film which is easily removable.</li> </ul>	<p><b>7. Handling and Storage</b></p> <p><b>Handling</b> Skin contact with hot materials should be avoided. Inhalation of fumes should be avoided as far as is reasonably practicable.</p> <p><b>Storage</b> No special requirements. Refer to the relevant Technical Data Sheet for the specific product.</p>
<p><b>5. First Aid Measures</b></p> <p><b>Summary of First Aid Procedures</b></p> <p><b>Inhalation</b> Immediately remove to fresh air. Seek medical attention.</p> <p><b>Skin Contact</b> Burns caused by contact with hot material should be cooled by immediately drenching with cold water. The bitumen may then be removed under medical supervision.</p> <p><b>Eye Contact</b> Irrigate with water for at least ten minutes. If pain persists seek medical attention.</p> <p><b>Ingestion</b> Remove to fresh air and give water to drink. Seek medical advice.</p>
